Overall Commentary

The Sphera Australian Microcap Fund returned 2.1% (after fees) during the month of February, outperforming the S&P/ASX Small Ordinaries Accumulation by 0.4%.

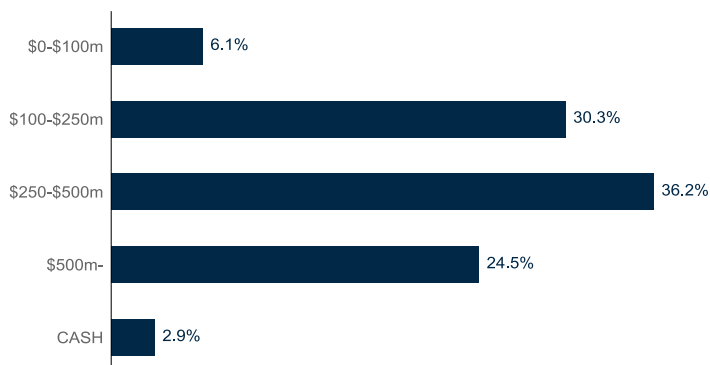
Smalls and micro-caps outperformed large caps over February continuing their strong rebound since October. Information technology and consumer discretionary sectors outperformed over reporting season, the latter we believe was due to low expectations heading into results.

Bravura Solutions (BVS.ASX), Nuix (NXL.ASX) and Adore Beauty (ABY.ASX) drove the relative outperformance. Ainsworth Game Technology (AGI.ASX), City Chic Collective (CCX.ASX) and Seven West Media (SWM.ASX) were notable detractors.

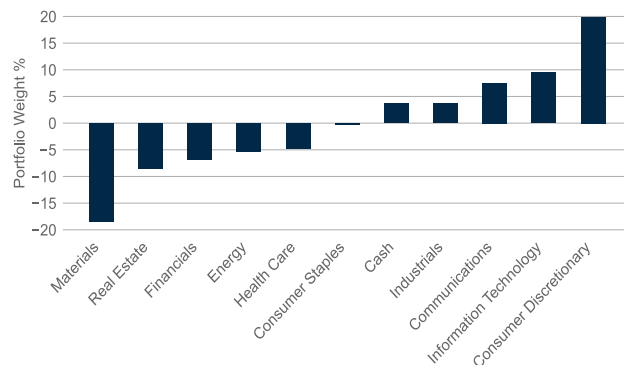
